FOODS ADULTERATED OR RECEIVED FROM UNAPPROVED SOURCES.

ITEM # 1H WAS FOUND IN VIOLATION 1 TIME(S). PUBLIC HEALTH HAZARD

Part or parts of the violation item were observed to be in violation which were corrected at the time of inspection.

Code Requirements

Food from unapproved source, spoiled, adulterated on premises.

Inspector Findings

An open box of frozen waffles found in the walk in freezer number 19 with condensate ice which has contaminated the waffles inside. Corrected: voluntarily discarded.

FOOD NOT PROTECTED IN GENERAL

ITEM # 8A WAS FOUND IN VIOLATION 2 TIME(S).

All or parts of the violation item are IN violation.

Code Requirements

Food not protected during storage, preparation, display, transportation and service, from potential sources of contamination (e.g., food uncovered, mislabeled, stored on floor, missing or inadequate sneeze guards, food containers double stacked)

Inspector Findings

1) Multiple five gallon pails which are designed for single use (pickle pails) being reused for the storage of food. 2) One carton of disposable food service containers stored in the dry goods area with sheetrock dust and pipe insulation on it. Two of the interior sleeves are open and the containers have been contaminated: Corrected, containers discarded. .

POOR SANITARY DESIGN, CONSTRUCTION, INSTALLATION OF EQUIPMENT AND UTENSILS.

ITEM # 10B WAS FOUND IN VIOLATION 1 TIME(S).

All or parts of the violation item are IN violation.

Code Requirements

Non-food contact surfaces and equipment are improperly designed, constructed, installed, maintained (equipment not readily accessible for cleaning, surface not smooth finish)

Inspector Findings

The floor in the walk in cooler 21 and 18 are worn and have several rust spots.

IMPROPER CONSTRUCTION AND MAINTENANCE OF PHYSICAL FACILITIES.

ITEM # 15A WAS FOUND IN VIOLATION 1 TIME(S).

All or parts of the violation item are IN violation.

Code Requirements

Floors, walls, ceilings, not smooth, properly constructed, in disrepair, dirty surfaces

Inspector Findings

Wall in dry storage downstairs room has two unsealed holes where pipes run through the wall.
